1	PRIORITY Review of marking	The review is conducted as a priority . This is a review of the original marking to ensure that the mark scheme has been applied correctly. Reviewers will not re-mark the script, they will only correct any errors identified in the original marking. This also includes the clerical re-checks detailed in Service 4. This service is available for all A-level qualifications and is usually only requested if your next level of education (e.g. university place) depends on the outcome. Pearson also offer this service for GCSE
2	PRIORITY Review of marking (as above service 1) with a copy of script.	As above (Service 1) with a copy of the exam script
3	PRIORITY copy of script to support deciding upon a review of marking	This is a priority service that ensures copies of scripts are received in time to decide whether a non-priority review of marking (service 5) should be applied for before the deadline
The services below are standard and should be applied for if the outcome does not affect the next level of education		
4	Non-priority clerical re-check	This service is to check that all parts of the script have been marked, the totalling of marks and the recording of marks are correct. Only this service can be requested for objective tests (multiple choice tests)
5	Non-priority review of marking	This is a review of the original marking to ensure that the mark scheme has been applied correctly. Reviewers will not re-mark the script, they will only correct any errors identified in the original marking. This also includes the clerical re-checks detailed in Service 4
6	Non-priority review of marking (as above service 5) with a copy of script	As above (Service 5) with a copy of the exam script
7	Non-priority copy of script with no other service	This is a non-priority service to request copies of scripts to support learning. <u>Once this has been ordered, you cannot then request a review of marking.</u>
